

**Official Rules - 2023 4th of July Celebration Sweepstakes
Ala Moana Center ("Mall")**

NO PURCHASE NECESSARY TO ENTER OR WIN. This promotion is not administered by, sponsored, endorsed, or associated with Instagram. This Sweepstakes is solely sponsored by Brookfield Properties Retail Inc. ("BPR" or "Sponsor").

ENTRY/DATES. Enter between July 1, 2023, 9:00 a.m. HST and July 4, 2023, 11:59 p.m. HST ("Promotional Period"). There are two methods of entry, an entrant is limited to only one entry during the Promotional Period.

1) Enter once using Instagram: visit www.instagram.com/alamoanacenter and look for our sweepstakes post and: i) like the post; ii) follow @alamoanacenter; and iii) tag one friend in the comments.
